## RECREATIONAL BENEFIT SCHEME REGULATIONS

### **1 ELIGIBILITY**

- 1.1 All Ordinary and General Branch Members of UTES are eligible to claim for the benefits under the Recreational Benefits Scheme.
- 1.2 An Ordinary or General Branch Member who is claiming the Recreational Benefit shall at the date of the qualifying event:
- (i) be a member for not less than six (6) months;
  - (ii) be a current member and not in arrears of subscriptions.

### **2 PROCEDURES & SETTLEMENT OF CLAIMS**

- 2.1 All claims shall be made in prescribed forms and submitted by the claimant to reach the Union not later than thirty (30) days from the qualifying event together with supporting documents or other evidence, if any.
- 2.2 All benefits payable shall be paid in one lump sum to the claimant. Payments shall be made through Inter-Bank GIRO as authorized by the claimant.

### **3 SUPPORTING DOCUMENTS**

- 3.1 Completed application forms must be accompanied with a copy of the Costa Sands Resorts Bill. The booking of the Costa Sands Resorts must be made under the claimant's name.

### **4 RECREATIONAL BENEFIT SCHEME**

- 4.1 Each eligible member as defined in (1.1) and (1.2) shall be entitled to a \$10 recreational claim per night of stay at the chalets under Costa Sands Resorts, inclusive of Downtown East, Costa Sands Pasir Ris, Costa Sands Sentosa only.
- 4.2 The recreational claim shall be limited to \$30 per eligible member per calendar year.
- 4.3 A one-time fund of \$12,000 has been set-up by UTES for the purpose of the Recreational Benefit Scheme.
- 4.4 The Scheme shall be effective for a period of one year from 1 January 2007 to 31 December 2007.
- 4.5 UTES reserves the right to amend the scheme from time to time.
